



**Wawasee Wrestling Club Registration Form**

Four years ago the club revamped its practice program. It proved to be very successful. We are seeing record numbers of kids in our club and we're hoping you will join us in the Wawasee Wrestling Family!

This season we will hold TWO practice sessions, on TUESDAY EVENINGS, divided into age groups. These practices are for our beginner level wrestlers with less than 3 years of experience.

Pre-K – 2<sup>nd</sup> Grade: 5:30 – 6:30PM

3<sup>rd</sup> Grade – 8<sup>th</sup> Grade: 6:30 – 8:00PM

All practices will be held in the high school wrestling room, located up the stairs in the northwest corner of the Annex Gym.

Registration and first practice will be held on Tuesday, Nov. 5. If you're unable to attend that evening, you may register at any Tuesday practice.

Practices will be held on Tuesdays from Nov. 5 until February 11th. **\*\*No practice over winter break\*\***

To participate you must be born 2019 or before.

The cost is \$65.00. This fee includes a t-shirt, instruction, and a USA card. You will be required to have a USA card for insurance purposes and to participate in wrestling events. The cost of a competition card is \$40.00 (provided as part of the club registration cost). ALL WRESTLERS USING THE WRESTLING ROOM FOR CLUB, MUST HOLD ONE OF THESE CARDS.
